**Resident Full Membership** allows full golf privileges, tennis, pool, clubhouse and dining privileges including involvement in all social related activities.

Initiation Fee: \$3,500.00      Deferred: \$3,750.00 (Requires 3 year Promissory Note)

Family Dues: Annually \$3,295.00 or Monthly \$288.32

Single Dues: Annually \$3,135.00 or Monthly \$274.32

**Resident Young Adult Full Membership** is available to any person who is thirty-five (35) and under (determined by age of older spouse) and allows full golf privileges, tennis, pool, clubhouse and dining privileges including involvement in all social related activities.

Initiation Fee: \$1,750.00      Deferred: \$1,875.00 (Requires 3 year Promissory Note)

Family Dues: Annually \$2,565.00 or Monthly \$224.45

Single Dues: Annually \$2,445.00 or Monthly \$213.95

### **“SOCIAL” MEMBERSHIP**

**Resident Social Membership** allows tennis, pool, clubhouse and dining privileges including involvement in all social related activities. Limited golf privileges are available with an applicable fee.

Initiation Fee: \$3,500.00      Deferred: \$3,750.00 (Requires 3 year Promissory Note)

Family Dues: Annually \$1,915.00 or Monthly \$167.57

Single Dues: Annually \$1,755.00 or Monthly \$153.57

**Resident Young Adult Social Membership** is available to any person who is thirty-five (35) years of age or under (determined by age of older spouse) and allows tennis, pool, clubhouse and dining privileges including involvement in all social related activities. Limited golf privileges are available with an applicable fee.

Initiation Fee: \$1,750.00          Deferred: \$1,875.00 (Requires 3 year Promissory Note)  
Family Dues: \$1,530.00 Annually or \$133.88 Monthly  
Single Dues: \$1,410.00 Annually or \$123.38 Monthly

**“NON-RESIDENT” MEMBERSHIPS** *Non-Resident members are responsible for an annual food and beverage minimum of \$100.*

**Non-Resident Full Membership** allows full golf privileges, tennis, pool, clubhouse and dining privileges including involvement in all social related activities.

Initiation Fee: \$1,000.00          Deferred: \$1,080.00 (Requires 3 year Promissory Note)  
Family or Single Dues: \$2,335.00 Annually or \$204.32 Monthly

**Non-Resident Social Membership** allows tennis, pool, clubhouse and dining privileges including involvement in all social related activities. Limited golf privileges are available with an applicable fee.

Initiation Fee: \$1,000.00          Deferred: \$1,080.00 (Requires 3 year Promissory Note)  
Family or Single Monthly Dues: \$1,410.00 Annually or \$123.38 Monthly

- ✚ **Family Membership:** Member, member’s spouse or “significant other” and dependants under the age of 25.
- ✚ **Single Membership:** An unmarried individual.
- ✚ **Non-Resident Status:** Persons residing in the area less than three months per year qualify for Non-Resident Membership.
