



Junior Programs

JUNIOR PROGRAM #1 - CHILDREN OF SOCIAL MEMBERS

Junior Program #1 involves the children, ages 0-24, of current Members of the Club who are not Full Members (Social Members). These children would be eligible to use the golf facilities for an annual fee of \$250.00 for the first child and \$400.00 for two or more children. If golf carts are used, the regular golf cart fee will be charged and the driver must have a legal driver's license.

The child's highest age at any point in the current year will determine his or her age for the purpose of this program. Children under the age of 14 must be accompanied on the Golf Course by an adult unless they have successfully completed the Junior Certification Program. (See the Golf Professional for details)

Restrictions: An orientation session with our golf professional will be required prior to the use of golf facilities covered in the Junior Program. Course is available at Golf Professional's discretion to prevent conflict with tournaments, outings, crowded regular play, etc.

Enrollment in this program must be done through the Club Business Office.

JUNIOR PROGRAM #2 - GRANDCHILDREN OF ALL MEMBERS

Junior Program #2 involves the grandchildren, ages 0-24, of all current Members of the Club. These grandchildren would be eligible to be added to the Family Membership at following rate:

\$150 Annually for each Non-Resident Grandchild

\$250 Annually for each Resident Grandchild

Member privileges, either Social or Full, are extended to the grandchild equal to that of the Member grandparent. Rates are based on the Primary Home Address of the Grandchild. Non-Resident is defined as not living on Virginia's Eastern Shore. If golf carts are used, the regular golf cart fee will be charged and the driver must have a legal driver's license.

The child's highest age at any point in the current year will determine his or her age for the purpose of this program. Children under the age of 14 must be accompanied on the Golf Course by an adult unless they have successfully completed the Junior Certification Program. (See the Golf Professional for details)

Enrollment in this program must be done through the Club Business Office.



JUNIOR PROGRAM #3 - CHILDREN OF NON-MEMBERS

Junior Program #3 involves children, ages 14-24, of people who are not Members of our Club. The program gives the child Full Membership privileges. Parents of the children involved would be required to “sign off” on bill responsibility. A limit of 12 children will be accepted annually; each one must be sponsored by a Club Member.

Restrictions: Course will be available with the prior approval of our Golf Professional to prevent conflict with tournaments, outings, crowded regular play, etc.

The child’s highest age at any point in the current year will determine his or her age for the purpose of this program. The cost of this Annual Program is \$300.00 per child ages 14 thru 18 or \$800 per child ages 19 thru 24. If golf carts are used, the regular golf cart fee will be charged and the driver must have a legal driver’s license.

Enrollment in this program must be done through the Pro Shop. An orientation session, including one or both parents, with our Golf Professional will be required prior to acceptance of the Application. During the orientation session, the rules and regulations of our Club, proper golf etiquette, and our expectations of proper behavior will be stressed. The Club reserves the right to terminate any participant from the Junior Program at any time with prepaid pro-rata portion of the program time refundable.
